**ATTENTION:**

-  For the purpose of this contract, NCCOC is the North Country Chamber of Commerce. (NCCOC)
-  **Vendors must provide their own tents, tables, chairs & set ups. Commercial pop up tents are strongly encouraged (make sure to secure with weight or stakes). All tents 400 square feet or larger must be inspected by the State Fire Marshall. Contact NCCOC for pricing and availability if you need a tent.**
-  No subleasing of your space or booth or any part of your space or booth is allowed. **We reserve the right to relocate your space or booth to maintain a quality show.**
-  Electricity & water are NOT available. Please bring your own **QUIET** generator if necessary. All generators must be safe, quiet and not interfere with traffic flow or fellow exhibitors or the public enjoyment of the festival.
-  Pre-packaged items such as farmer’s market type goods or bake sale items may be sold by any vendor. Free samples of food are allowed.
-  **SET-UP:** Vendors shall be set up and ready for business by 8:30 AM Friday. Vendors with large trailers should be in position early in the week before the tents are set up to allow adequate space. Indicate the size trailer you will have and when it will be there so that we can accommodate your needs. The manufacturers should aim to have their units at the site on or before Wednesday of that week. We can accommodate them here as early as the Saturday before the event.
-  **INSURANCE:** All vendors are required to provide a Certificate of Insurance for public liability. This is proof of your business insurance, which will protect your booth space, yourself, anything and anyone related to your booth’s functioning. **Minimum coverage of \$1,000,000 is required and NCCOC (its agents, employees, officers and members of the Board of Directors), GoNorth SnoFest, and NH Division of Parks and Recreation shall be named as additional insured on this policy.** All vendors are required to show proof of Workers’ Compensation coverage for any employee, agent and/or representative.
-  The GoNorth SnoFest committee reserves the right to decline or prohibit any applicant, exhibit, display or activity which is not suitable to the spirit of the GoNorth SnoFest. This is a family friendly event focused on showcasing northern New Hampshire and northeastern Vermont.
-  Vendor is responsible for all of their personal and business property at the GoNorth SnoFest and will not hold the North Country Chamber of Commerce (NCCOC), the GoNorth SnoFest committee or NH Division of Parks and Recreation liable for any damages, personal injury or theft that might occur at the event.
